Glenwood Recreation Club, Inc. 2023 Annual Membership Meeting Minutes

Thursday, March 9, 2023 ~ 7:30 PM ~ Knights of Columbus

1. Welcome and Introductions (Slattery)

A quorum established, Board President Brian Slattery called the meeting to order at 7:33 PM.

Brian introduced the members of the Board and thanked them for their service.

2. Approval of <u>2022 Annual Meeting Minutes</u> (Coyne)

Upon a motion by Ella lams (seconded by Roland Schrebler), the minutes of the February 17, 2022, Glenwood Annual Meeting were approved without revision.

3. Membership Report (Chen)

Board member Sandie Chen reported on behalf of Membership Director Kathleen Enright. Membership stands at capacity at around the 525 target for membership families. Today there are 479 families on the waitlist.

Dues can be paid online as soon as tonight's meeting concludes; the deadline is April 1 to avoid any late fees. A higher late fee kicks in after April 15. After April 15, members will have to reach out to the Membership Director to find whether space is available before they can pay their dues and continue their membership. 4. Winter Activity Update (Slattery / Ginter)

Winter activities included repairs to some of the pool infrastructure (tiles and coping stones), new roofs for manager's office, pumphouse and shed, re-strapped chairs, concrete repairs on terrace, landscaping, terrace wall repairs, new wooden benches, tree removal and tree planting.

5. Parking Lot Planning Update (Martin)

Ted Martin reported on the ongoing erosion / drainage issues. Our parking re-development plan has been slowed by permitting approval processes. We hope to be able to complete this significant project prior to the 2024 summer season.

6. Financial Report and Budget (Bhandari; p.2)

Treasurer Brian Bhandari reported on the financial health of Glenwood. The Board continues to aggressively pay down our current mortgage balance, with additional \$1,000 payments each month; it is projected to be paid off in 2027. Some FY2022 expense savings were due to deferral of capital projects into FY2023. We are continuing to follow our long-term capital maintenance schedule. In addition, we recently moved a significant amount of our reserves into Certificates of Deposit to take advantage of rebounded interest rates.

This year's budget is break-even and reflects a 3% dues increase, as follows:

Upon a motion by Jeff Roddin (seconded by Ella Iams), the membership accepted the FY2023 Glenwood operating budget.

7. Swim Team & Dive Team (Hur & Schreiber)

Cara Hur reported on behalf of the fellow Swim Team Reps (Tracy Vagnucci, Darcia Bowman and newcomer Julie Roddin. New swimmer screenings will begin on Tuesday, May 30 and each swimmer will be directed toward the Big Team, the Pre-Team or to Summer Lessons. The schedule of practices, meets and events will be very similar to 2022. Glenwood is the second seed in the Montgomery County Swim League's Division E. The Swim/Dive Winter Dance will take place at the Knights of Columbus on March 11. The coaching application deadline is March 31. Please send questions to <u>swimteamrep@glenwoodpool.org</u>.

Ramona Schreiber reported on behalf of fellow Dive Team Reps Lara and Zac Morford). The team was the second largest in the Montgomery County Dive League in 2022. Of 71 divers, 40 were 10 and under last year. Nearly 10% of the divers at

the recent Metros Meet were from Glenwood. The team is seeded first in Division 2. Dive practices will start Wednesday, May 31. The schedule of practices, meets and activities will be similar to 2022. Please send questions to <u>diveteamrep@glenwoodpool.org</u>.

Joe Carnell reported on behalf of the co-staff directors Sandie Chen and Leo Schwartz. Sean Hennigan will return as Manager. Continuing established practice, each returning lifeguard must reapply to be considered for employment in 2023. - Proposed Glenwood Recreation Club By-Law Amendments (Martin) Ted Martin reviewed the board's process in re-organizing and modernizing the by-laws and thanked members Kathleen McClellan, Cara Hur, Roland Schrebler, and Ramona Schreiber for their detailed assistance. Ted reviewed each substantive proposed by-law amendment. Susan Massey suggested clarifying in a future amendment that the wait list is exclusively managed based on the date joined, oldest to newest, which the board will keep under consideration and address in a future by-laws revision. Upon a motion by Ellan Iams (seconded by Elliot Zenick), the by-law amendments were approved as presented.
